



Crynodeb Gweithredol: Mae hwn yn gais i ddarparu arian grant i recriwtio Gweithiwr Achos Caethwasiaeth Fodern i weithio yn y Ganolfan Cymorth i Ddioddefwyr yn Llanelwy, Sir Ddinbych. Pwrpas y rôl hon yw rheoli cyswllt â dioddefwyr Caethwasiaeth Fodern yng Ngogledd Cymru. Bydd y Gweithiwr Achos yn gweithio ar y cyd â Heddlu Gogledd Cymru a'r Corff Anlywodraethol BAWSO enwebedig. Bydd deiliad y swydd yn nodi a rheoli anghenion gwasanaeth diod y dioddefwyr ac yn cyfrannu at brosesau asesu risg. Y rôl hon yw'r gyntaf o'i bath o fewn gwasanaethau i ddioddefwyr ar draws y DU, a bydd yn rhoi cymorth annibynnol i ddioddefwyr, gan ddarparu pwyt cyswllt penodol ar eu cyfer, yn ogystal â rheoli achosion o'u dechrau i'w diwedd.	Executive Summary: This is a request to provide grant funding to recruit a Modern Day Slavery Caseworker based within the Victim Help Centre in St Asaph, Denbighshire. The purpose of this role is to manage contact with victims of Modern Day Slavery (MDS) in North Wales. The Caseworker will be working in liaison with North Wales Police and None Govermental Orgnisaiton (NGO) BAWSO. The post will identify and manage the victims' immediate service needs and contribute towards risk assessment processes. This role is the first of its kind within victim services across the UK and it will be giving (MDS) victims independent support, providing them with a specific point of contact together with case management from start to finish.

Implications: Financial – A contribution of £38,376.00 has been made available from the Crime and Disorder Grant 2022/23.
