<b>Crynodeb Gweithredol:</b>  Bydd y Comisiynydd Heddlu a Throedd yn ymestyn ei gyfraniad o arian i gefnogi rôl Rheolwr Rhanbarthol Crimestoppers dros ardal y Gogledd Orllewin.  Pwrpas y prosiect yw codi ymwybyddiaeth a chudd-wybodaeth cymunedol yn unol â'r blaenoriaethau o fewn y Cynllun Heddlu a Throedd. Ei nod yw annog unigolion, phlant bregus a'r gymuned i roi gwybodaeth i'r elusen yn ddienw. Mae'r cynnydd mewn adrodd cymunedol ar droseddau yn gynnar yn gallu lleihau troseddau yn eu hardaloedd.	<b>Executive Summary:</b>  The Police and Crime Commissioner will extend his contribution of funding to support the role of the Crimestoppers Regional Manager for the Northwest region.  The purpose of this project is to increase awareness and community intelligence in line with the priorities in the Police and Crime Plan. It aims to empower vulnerable individuals, children, and the community by encouraging trust in them to report/give information to the charity anonymously. This increase in community reporting of crimes at an early stage can make a difference in reducing crime in their local area.
<b>Goblygiadau:</b>  Ariannol – Mae £15,000.00 ar gael o Grant Troedd ac Anhhrefn y Comisiynydd 22/23 i gynorthwyo'r gwaith arloesol hwn.  Cyfreithiol – Mae Deddf Diwygio'r Heddlu a Chyfrifoldeb Cymdeithasol 2011 yn galluogi'r Comisiynydd i roi grantiau i bartneriaid, sefydliadau cyhoeddus neu grwpiau gwirfoddol i gynorthwyo blaenoriaethau sydd yn y Cynllun Heddlu a Throedd. Mae hefyd yn gyfrifol am ofyniad gweithredol Gogledd Cymru fel rhan o Unedau Troseddau Trefniadol Rhanbarthol (ROCU) yn ogystal â'r angen i fod yn rhan o Grŵp Heddlu Cymru Gyfan.	<b>Implications:</b>  Financial – £15,000.00 has been made available from the Commissioner's Crime and Disorder Grant 22/23 to support this innovative work.  Legal – The Police Reform and Social Responsibility Act 2011 enables the Commissioner to award grants to partners, public organisations or voluntary groups that can support the community safety priorities identified in the Police and Crime Plan. It also accounts for the operational requirement of North Wales Police as part of the Northwest Regional Organised Crime Units (ROCU) as well as the need to be part of the All-Wales Forces Group.  Police and Crime Plan – Working with the Regional Manager will allow the Force and the PCC access to the Crimestoppers organisation and its expertise in crime reduction, marketing, and communications. It will also assist in promoting fundraising and volunteer opportunities within North Wales. This work will be monitored through performance data, case studies and management information.
