



<b>Crynodeb Gweithredol:</b>  Mae'r Cynllun Braenaru Merched yn gynllun dargyfeirio a gomisiynwyd i gynorthwyo troseddwyr benywaidd i osgoi trfferth gyda'r gyfraith a llywio merched i ffwrdd o drosedd drwy ddarpar u cyfleoedd i ddiwygio ac ailsefydu.  Gwnaiff prosiect y Cynllun Braenaru Merched ddarparu ymyriadau i ferched sydd wedi cael dargyfeirio drwy'r gwasanaeth Checkpoint mewn Dalfeydd yn hytrach na chael eu cyhuddo o drosedd lefel is. Mae'r gwasanaeth hefyd yn derbyn merched mewn perygl o fynd i'r system Cyflawnder Troseddol a gall merched gael eu cyfeirio drwy asiantaethau neu hunan – atgyweirio yn yr amgylchiadau hyn.  Mae'r cytundeb hwn yn dod i ben ar 30 Medi 2022.	<b>Executive Summary:</b>  The Women's Pathfinder is a diversion scheme commissioned to help and support women reduce reoffending. By understanding the underlying causes of their offending behaviours, pathfinder will steer women away from crime by providing opportunities to reform and rehabilitate.  The Women's Pathfinder project will provide interventions to women who have been diverted via the Custody based Checkpoint service as an alternative to being charged for low level offence. The service also accepts women who are at risk of entering the Criminal Justice system and women can be referred through agencies or self-refer in some circumstances.  This contract is ends on the 30 <sup>th</sup> of September 2022.	
<b>Goblygiadau:</b>  Ariannol – Mae £176,920.00 ar gael o Gronfa Trosedd ac Anrhewf 22/23 wedi'i ddarparu gan y Comisiynydd Heddlu a Throseredd er mwyn cynorthwyo'r gwaith arloesol hwn.  Cynllun Heddlu a Throseredd – Bydd y maes gwaith hwn yn cynorthwyo'r Comisiynydd fodloni ei brif ddyletswydd statudol o gyflawni gwasanaeth plismona effeithiol ac effeithlon yng Ngogledd Cymru. Bydd y gwaith hwn yn cael ei fonitro drwy'r Bwrdd Cymunedau Diogelach lle gosodir diweddarriadau cyflawniad.  Cyfreithiol – Mae Deddf Diwygio'r Heddlu a Chyfrifoldeb Cymdeithasol 2011 yn galluogi'r Comisiynydd i roi grantiau i bartneriaid, sefydliadau cyhoeddus neu grwpiau gwirfoddol a all gynorthwyo'r blaenoriaethau diogelwch cymunedol a nodwyd yn y Cynllun Heddlu a Throseredd.	<b>Implications:</b>  Financial – £176,920.00 has been made available from Crime and Disorder Grant 22/23 provided by the Police and Crime Commissioner to support this innovative work.  Police and Crime Plan – This area of work will help the Commissioner meet his main statutory duty of delivering an effective and efficient policing service in North Wales. This work will be monitored through the Safer Communities Board where performance updates will be tabled.  Legal – The Police Reform and Social Responsibility Act 2011 enables the Commissioner to award grants to partners, public organisations or voluntary groups that can support the community safety priorities identified in the Police and Crime Plan
