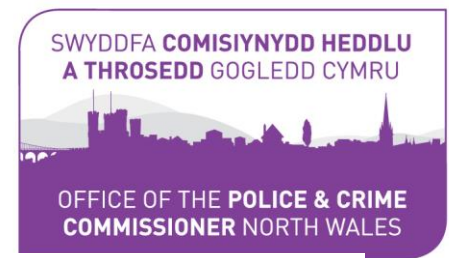

Crynodeb Gweithredol:	Executive Summary:
<p>Yn ystod 2021 cyhoeddodd y Llywodraeth gynnydd pellach i gyllideb y Weinyddiaeth Gyfiawnder er mwyn cynyddu cymorth i ddioddefwyr.</p> <p>Yn dilyn cyflwyno'r anghenion a nodwyd yng Ngogledd Cymru, mae'r Weinyddiaeth Gyfiawnder wedi dyrannu cyllid ychwanegol i gynorthwyo cam-drin domestig a thrais rhywiol gan gynnwys Ymgynghorwyr Trais Rhywiol Annibynnol ac Ymgynghorwyr Cam-drin Domestig Annibynnol.</p> <p>Oherwydd yr heriau mae buddsoddiad tymor byr yn ei achosi i gomisiynwyr a'r gwasanaeth sy'n cyflawni'r cymorth, cadarnhaodd y Weinyddiaeth Gyfiawnder y bydd y cyllid ar gael tan 2025. Bydd y Weinyddiaeth Gyfiawnder hefyd yn ymestyn y cyllid ISVA/IDVA a ddyrannwyd yn 2021 ynghyd â'r cyllid Cymorth Treisio tan 2025.</p> <p>Mae'r hysbysiad penderfyniad hwn yn cadarnhau bwriad y Comisiynydd ar gyfer dyrannu Cyllid ISVA/IDVA ychwanegol y Weinyddiaeth Gyfiawnder.</p> <p>Mae'r dyraniad cyllid ynghlwm i'r hysbysiad penderfyniad hwn.</p>	<p>During 2021 the Government announced a further increase to the MOJ budget to increase support for victims.</p> <p>Following a submission of the needs identified in North Wales the Ministry of Justice have allocated additional funding to support domestic abuse and sexual violence including Independent Sexual Violence Advisors and Independent Domestic Abuse Advisors.</p> <p>Due to challenges that short term investment causes for commissioners and services delivering the support, the MOJ confirmed that the funding will be available until 2025. The Ministry of Justice will also be extending the ISVA/IDVA funding which was allocated in 2021 together with the Rape Support funding until 2025.</p> <p>This decision notices confirms the Commissioner's intentions for the distribution of the MOJ additional ISVA/IDVA Funding.</p> <p>Allocation of funding is attached to this decision notice.</p>

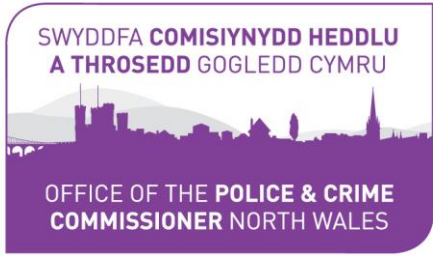

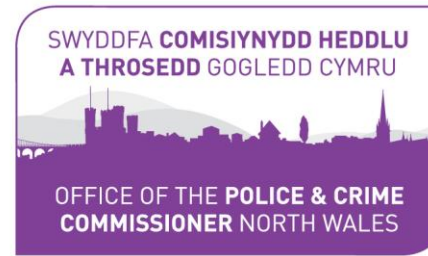

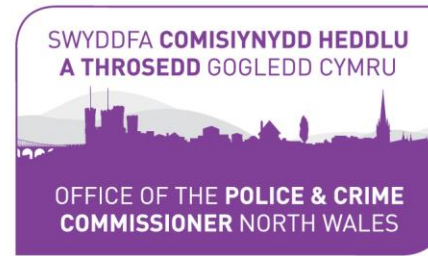
