Yn dilyn cynnydd sylweddol mewn atgyfeiriadau a rhestr aros gynyddol, mae'r Comisiynydd Heddlu a Throsedd wedi dyrannu £10,000.00 i RASASC er mwyn cynorthwyo Cwnselydd Plant a Phobl Ifanc a wnaiff roi cymorth therapiwtig arbenigol i Blant a Phobl Ifanc sydd wedi profi unrhyw fath o Gam-drin Rhywiol ar Blant, Cam-drin Rhywiol a/neu Dreisio.	Following a significant surge in referrals and an increased waiting list the Police and Crime Commissioner has allocated a £10,000.00 to RASASC to support a Children and Young People Counsellor who will provide specialist therapeutic support to Children and Young People who have experienced any form of Child Sexual Abuse, Sexual Abuse and/or Rape.
