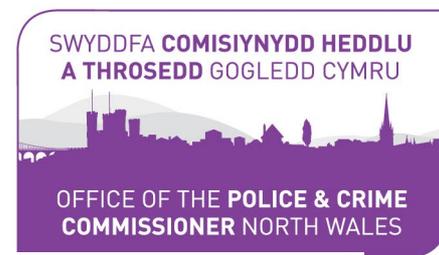



Crynodeb Gweithredol:	Executive Summary:
Derbyniwyd gohebiaeth reolaidd gan y cyhoedd i'r CHTh yn uniongyrchol ac i SCHTh yn codi pryderon am y ffordd mae Heddlu Gogledd Cymru yn gorfodi Deddf Hela 2004. O ganlyniad, gwnaeth y CHTh gomisiynu adolygiad annibynnol. Ystyriodd yr adolygiad hwn pa mor dda mae'r Ddeddf Hela yn cael ei phlismona yng Ngogledd Cymru ac a oes unrhyw feysydd i'w gwella.	Regular correspondence was received from the public to the PCC directly and to the OPCC raising concerns regarding the way North Wales Police enforce the Hunting Act 2004. As a result, the PCC commissioned an independent review. This review considered how well the Hunting Act is policed in North Wales and whether there are any areas for improvement.

Mae troseddau cefn gwlad a bywyd gwyllt yn cael eu hymgorffori o fewn y flaenoriaeth gyffredinol oherwydd yr effaith sylweddol gall trosedd ei gael ar gymunedau cefn gwlad diarffordd.</p> <p>Y Gymraeg – Cyfieithir yr adroddiad terfynol cyn ei gyhoeddi. Gall y tîm adolygu gyfathrebu gyda rhanddeiliaid drwy'r Gymraeg os mai dyma eu hoff ddull o gyfathrebu.</p> <p>AD – Bydd swyddogion perthnasol ac aelodau staff o fewn HGC yn cael eu hymgynghori fel rhan o'r adolygiad hwn.</p> <p>Cydraddoldeb – Bydd rhan o'r adolygiad hwn yn cynnwys arolwg cyhoeddus. Bydd fersiwn darllen hawdd o'r arolwg ar gael.</p>	<p>Financial – The review is anticipated to cost £19,390.50, to be funded from the Community Safety Budget.</p> <p>Police and Crime Plan – Delivering Safer Neighbourhoods is the overarching priority and sets the foundation of the Police and Crime Plan. Rural and Wildlife crime are incorporated within this overarching priority due to the significant impact that crime can have on secluded rural communities.</p> <p>Welsh language – The final report will be translated prior to publication. The review team also can communicate with stakeholders through Welsh if that is their preferred method of communication.</p> <p>HR – Relevant officers and members of staff within NWP will be consulted as part of this review.</p> <p>Equality – Part of the review will include a public survey. An easy read version of the survey will be made available.</p>
