



<b>Crynodeb Gweithredol:</b>  Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y gorchmynion sefydlog o ran caffael y gwasanaeth i osod erialau ar gerbydau heddlu.  Mae'r gwasanaeth ar hyn o bryd yn cael ei ddarparu gan ddarparwr lleol achrededig pwrpasol. Nhw sy'n dylunio, gweithgynhyrchu ac yn cyflenwi'r offer a'r gwasanaeth angenrheidiol.  Mae'r cwmni yn darparu gwasanaeth o ansawdd uchel ar gyfer Heddlu Gogledd Cymru.  Bydd y cyfnod cytundeb am gyfnod o ddwy flynedd gyda'r opsiwn i ymestyn am 3 blynedd arall mewn cynyddrannau blynyddol. Cyfanswm gwerth y cytundeb dros y cyfnod llawn o 5 mlynedd ydy £51,200.  Gellir hepgor gorchmynion sefydlog o ran yr angen i gynnig cytundeb os ydy'r gofyn yn arbenigol ei natur. Gellir ond ei ddarparu'n rhesymol gan gyflenwr unigol.	<b>Executive Summary:</b>  North Wales Police have requested a waiver in the standing orders in relation to the procurement of the service to fit aerials to police vehicles.  The service is currently provided by a bespoke accredited local provider, they are the design, manufacturer and supplier of the equipment and service required.  The company are providing a high-quality service to North Wales Police.  The contract period will be for a period of two years with the option to extend for a further 3 years in annual increments. The total value of the contract over the full 5-year period is £51,200.  Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.
