Mae'r prosiect eisoes wedi cael ei gyflwyno i bobl ifanc rhwng 14-25, ond bydd yr arian yn gweld yr ymgyrch yn ymestyn i gynulleidfa ehangach mewn ysgolion uwchradd, colegau 6ed dosbarth a'r Brifysgol, gyda'r posibilrwydd o'i gynnwys i glybiau chwaraeon fel clybiau rygbi.  Mae'r prosiect eisoes wedi cael ei baratoi gan RASASC, felly dim ond y sefydliad hwnnw all ei gyflenwi.  Gall Gorchmynion Sefydlog yng nghyswllt gofynion cytundeb tendro gael eu hildio os yw'r gofynion yn arbenigol yn ei natur ac all ond cael ei ddarparu yn rhesymol gan gyflenwr unigol.	<b>Executive Summary:</b>  North Wales Police have requested a waiver in the standing orders in relation to the delivery of the training "Don't steal my future" campaign.  The project has already been delivered to young people between the ages of 14-25, but the funding will see a continuation of the campaign to a wider audience into the secondary schools, 6th Forms and the University, with scope to deliver into sport clubs such as Rugby.  The project has already been prepared by RASASC, therefore can only be delivered by them.  Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.
