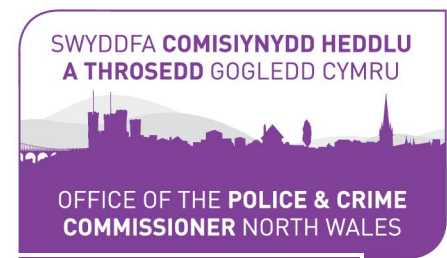

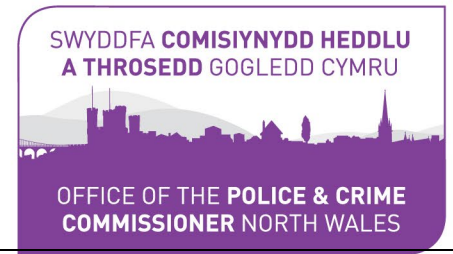

The service is being delivered on an All-Wales basis to a very high standard.</p> <p>This contract has a value of £23,920 for 12 months.</p> <p>Standing orders in relation to the requirement to tender a contract may be waived to allow an extension to avoid a disruption in delivering a policing service.</p> |
