



Mae'r cytundeb hwn werth £23,920 am 12 mis. Gellir hepgor gorchmynion sefydlog o ran yr angen i dendro cytundeb er mwyn caniatáu estyniad i osgoi aflonyddwch mewn cyflawni gwasanaeth plismona.	Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the procurement of a provider to assess police officers, PCSO and Specials on Verbal Reasoning and Calculation Assessments. The service is already delivered by a contract and the Force are requesting an extension of that contract for 12 months. The service is being delivered on an All-Wales basis to a very high standard. This contract has a value of £23,920 for 12 months. Standing orders in relation to the requirement to tender a contract may be waived to allow an extension to avoid a disruption in delivering a policing service.
