

<b>Crynodeb Gweithredol:</b> Mae gan y Comisiynydd Heddlu a Throseredd a'r Prif Gwnstabl Lawlyfr Llywodraethu ar y Cyd. Adolygywyd hwn yng ngwanwyn 2023, ac fe ail-gadarnhawyd y dogfennau presennol yn y Bwrdd Gweithredol Strategol ar 10 Mai 2023.	<b>Executive Summary:</b> The Police and Crime Commissioner and Chief Constable have a joint Manual of Governance. This was reviewed in spring 2023, and the current documents re-ratified at Strategic Executive Board on 10 May 2023.
<b>Goblygiadau:</b> Ariannol – Mae'r Rheoliadau Ariannol, y Gorchmynion Sefydlog ar gyfer Cytundeb, a'r Cynllun Caniatâd yn elfennau gorfodol y Llawlyfr Llywodraethu. Y Cynllun Heddlu a Throseredd – Mae trefniadau llywodraethu iawn yn angenrheidiol er mwyn cyflawni'r cynllun heddlu a throseredd. Y Gymraeg – dim goblygiadau ar wahân. AD – Ceir canllawiau lefel uchel o ran talu staff o fewn y Rheoliadau Ariannol. Cydraddoldeb – dim goblygiadau ar wahân.	<b>Implications:</b> Financial – The Financial Regulations, Standing Orders for Contracts, and Scheme of Consent are compulsory elements of the Manual of Governance. Police and Crime Plan – Proper governance arrangements are necessary to deliver the police and crime plan. Welsh language – no separate implications HR – High level guidance regarding the payment of staff is included within the Financial Regulations Equality – no separate implications.
