Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the procurement of a warranty for a Dell Server. This warranty is specifically for a server already owned by North Wales Police; the warranty is required for one year whilst a new server is being sought. This contract has a value of £27,485.30 Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier or for a short-term period.
