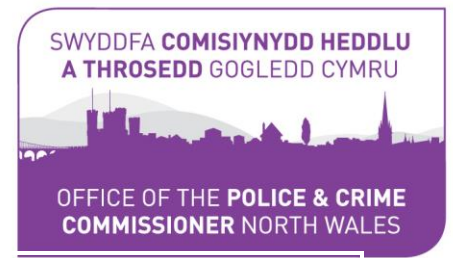


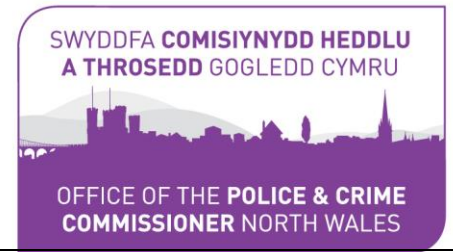

<p>Mae'r gwaith hwn wedi ei gomisiynu mewn ymateb uniongyrchol i'r disgwyliadau sydd wedi eu hamlinellu gan y Swyddfa Gartref fel rhan o ofynion Dyletswyddau Troseddau Trais Difrifol.</p> <p>Mae gofyn i CHTH ar y cyd ag awdurdodau penodol ddarparu strategaeth ymateb i Asesiad Anghenion Trais Difrifol a fydd yn rhoi gwybod am gynlluniau gwaith y dyfodol o Ebrill 2024 ymlaen.</p> <p>Yr SCCh yw deiliad y grant sy'n cymryd rôl y prif gydlynnydd, yn cefnogi datblygu a rhoi'r Dyletswydd Trais Difrifol ar waith.</p> <p>Rhaid i'r gwaith ddod i ben ar ddiwedd Rhagfyr 2024 i gyrraedd dyddiad cau 31 Ionawr 2025 yn unol â gofynion y Swyddfa Gartref.</p> <p>Y bwriad yw i'r ddyletswydd yng Ngogledd Cymru gael ei gyrraedd ar lefel plismona lleol, gyda gofynion dyletswydd yn cael ei gyflenwi gan Bartneriaeth Trais Difrifol.</p>	<p>This work has been commissioned in direct response to the expectations outlined by the Home Office as part of the Serious Violence Duty requirements.</p> <p>The OPCC in collaboration with specified authorities is required to provide a response strategy to a Serious Violence Needs Assessment that will inform the future work plans from April 2024 onwards.</p> <p>The OPCC are the grant holder and take on the lead convenor role, supporting the development and implementation of the Serious Violence Duty.</p> <p>This work must conclude at the end of December 2024 to meet the deadline of 31<sup>st</sup> January 2025 in line with Home Office requirements.</p> <p>The intention is for the duty in North Wales to be met at a local policing level, with duty requirements being delivered by the Serious Violence Partnership.</p>

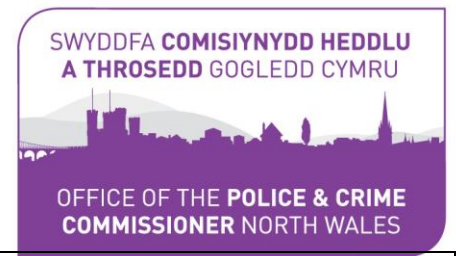
