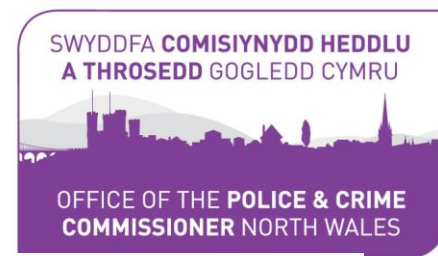

<p>Mae'r hysbysiad penderfyniad hwn yn cadarnhau bwriad y Comisiynydd i roi £50,000 er mwyn cynorthwyo'r rhaglen IRIS am chwe mis yn Sir Ddinbych.</p> <p>Mae'r rhaglen IRIS yn cynnig gwasanaeth cofleidiol therapiwtig ar gyfer dioddefwyr cam-drin domestig risg uchel sy'n mynd i wasanaethau iechyd. Mae'r prosiect yn darparu ymyriad ar sail tystiolaeth sy'n gwella ymateb meddygon teulu i gam-drin domestig.</p> <p>Gwnaiff yr addysgwr eirioli cam-drin domestig weithio ar draws 8 meddygfa teulu yn Sir Ddinbych, gan ddarparu cymorth arbenigol i gleifion sydd â mynediad i wasanaethau iechyd mewn meddygfa deulu. Gwnaiff y gweithiwr gynorthwyo goroeswyr sydd â mynediad i'r gwasanaethau iechyd fyw heb ofn yn niogelwch eu cartrefi eu hunain, atal digartrefedd a chaniatáu iddynt ffynnu yn dilyn effaith cam-drin domestig.</p>	<p>This decision notice confirms the Commissioner's intention to provide £50,000 to support the IRIS programme for six months in Denbighshire.</p> <p>The IRIS programme offers a therapeutic wraparound service for high-risk Domestic Abuse victims entering health services. The project provides an evidence-based intervention that improves General Practitioners response to Domestic Abuse.</p> <p>The domestic abuse advocate educator will work across 8 GP surgeries in Denbighshire providing specialist support to patients that access health services in a GP Setting. The worker will assist survivors accessing health services to live fear free in the safety of their own homes, preventing homelessness and allowing them to thrive following the impact of Domestic Abuse.</p>
