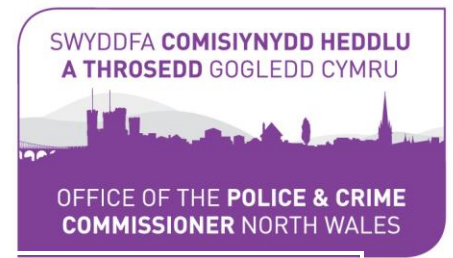


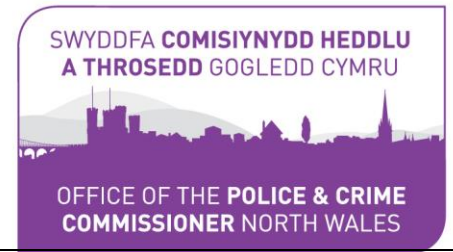

Mae'r cyllid hwn wedi gallu rhoi sefydlogrwydd i wasanaethau allweddol.</p> <p>Mae dyraniad y cyllid ynghlwm wrth yr hysbysiad penderfyniad hwn.</p>	<p>This decision notice confirms the Commissioner's intention for the financial year 2024/2025, for the distribution of the Victims Services Grant.</p> <p>The Commissioner has agreed to continue funding for all the services which provide direct support for victims of crime in the region.</p> <p>Without this much needed support provision would not be in place for Independent Domestic Violence Advisors, Independent Sexual Violence Advisors, Child Sexual Assault support and the Victim Help Centre across the region. This funding has been able to provide stability for key services.</p> <p>Allocation of funding is attached to this decision notice.</p>

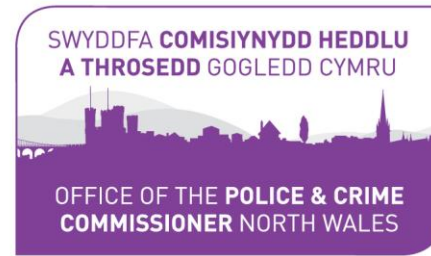

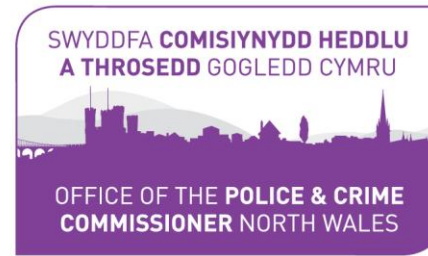

Recipient	Total Amount	Service and Purpose
Victim Support	£390,791.00	To commission a Victim Help Centre to provide a support service for victims of crime.
Grŵp Cynefin-Gorwel	£70,397.14	To provide funding to support the Regional Independent Domestic Violence Service in Gwynedd and Anglesey.
Domestic Abuse Safety Unit	£194,896.56	To provide funding to support the Regional Independent Domestic Violence Service in Denbighshire, Conwy, Flintshire and Wrexham.
Sexual Assault Centre, BCUHB	£103,000.00	To provide funding for 2 full time Independent Sexual Violence Advisors (ISVAs). This contribution will support the provision of an enhanced Children and Young People's Sexual Violence Advisor.
Rape and Sexual Assault Centre	£56,600.00	To provide funding for 2 counsellors to support young victims of sexual violence and child sexual abuse and a multi-media campaign to combat sexual violence.
