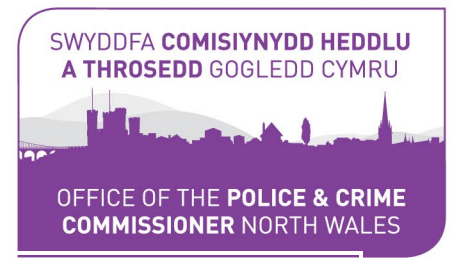

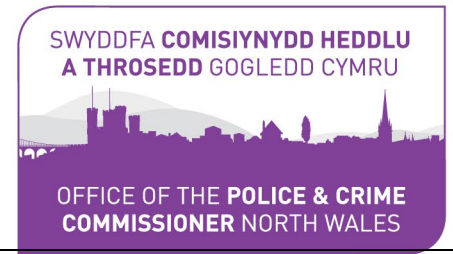

Crynodeb Gweithredol: <p>Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y gorchmynion sefydlog o ran caffael cymorth am feddalwedd cymwysiadau amrywiol sy'n cael eu defnyddio gan yr heddlu. Mae hyn yn cynnwys cymwysiadau ar gyfer unigolion coll, iechyd a diogelwch, ymholiadau tocynnau cosb a dadleniadau i GEG. Mae'r cymhwysiad unigolion coll ond ei angen am 12 mis arall. Gall y lleill gael eu newid yn y 4 blynedd nesaf. Felly, mae angen yr hepgoriad tan fis Ebrill 2025 ac o bosib am y 2 i 4 blynedd nesaf tra maent yn cael eu hamnewid.</p> <p>Mae Heddlu Gogledd Cymru yn defnyddio'r meddalwedd. Nid oes problemau i'w adrodd hefo'r gwasanaeth, er mae cynlluniau i newid yn y dyfodol.</p>	Executive Summary: <p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of support for software for various applications used by the force. To include applications for missing persons, health and safety, ticketing queries and disclosures to CPS. The missing persons application is only required for a further 12 months, and others may be replaced in the next 4 years. The waiver is therefore required until April 2025 and possibly for the next 2 to 4 years while they are replaced.</p> <p>The software is already being used by North Wales Police and there are no issues reported with the service, although there are plans to replace in the future.</p>
