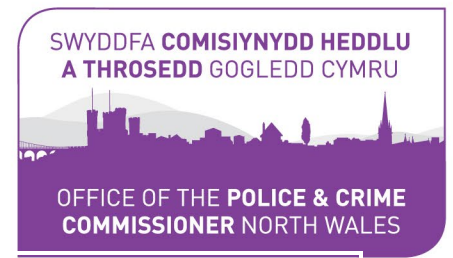

<p>Mae'r Comisiynydd Heddlu a Throsedd yn Awdurdod Goruchwyllo Pensiynau (AGP) dros swyddogion heddlu yng Nghymru a Lloegr.</p> <p>Mae dyletswydd gan yr AGP weithio efo'r heddlu er mwyn nodi a gweinyddu achosion a gaiff eu hystyried i'w fforffedu gan yr heddlu. Er mwyn sicrhau cysondeb ac amseroldeb ceisiadau fforffedu pensiynau i'r Swyddfa Gartref, mae gofyn bod y Comisiynydd Heddlu a Throsedd yn dirprwyo ei rôl i'w ymgynghorydd proffesiynol, sef y Prif Weithredwr yn ei swyddfa. Mae'r Prif Weithredwr wedi ei ddirprwyo'n briodol efo'r awdurdod i ystyried pob dyletswydd statudol arall sydd wedi'u gosod ar y Comisiynydd Heddlu a Throsedd yn ymwneud â materion cwynion ac ymddygiad. Bydd y ddirprwyaeth ychwanegol hon yn darparu'r wybodaeth arbenigol sydd ei hangen er mwyn gwneud penderfyniadau teg.</p>	<p>The Police and Crime Commissioner is the Pension Supervising Authority (PSA) for police officers in England and Wales.</p> <p>There is a duty on the PSA to work with the Police Force to identify and administer cases to be considered for police forfeiture. To ensure consistency and timeliness of pension forfeiture applications submitted to the Home Office it is requested that the Police and Crime Commissioner delegates this role to his professional advisor the Chief Executive of his office. The Chief Executive is the delegated appropriate authority to consider all other statutory duties imposed on the Police and Crime Commissioner in relation to complaint and conduct matters. This further delegation will provide the expertise required to make fair decisions.</p>
