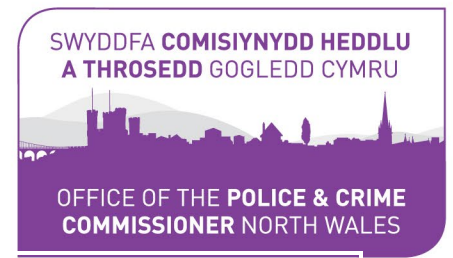

<p>Mae Ymddiriedolaeth yr Heddlu a'r Gymuned (PACT) yn rheoli rhan o'r Gronfa Deddf Enillion Troseddau ar ran Comisiynydd Heddlu a Throsedd a Phrif Gwnstabl Gogledd Cymru.</p> <p>Mae arian o'r Gronfa Deddf Enillion Troseddau yn cael ei ddefnyddio er mwyn prosiect "Eich Cymuned, Eich Dewis" y Comisiynydd. Mae "Eich Cymuned, Eich Dewis" yn ddull o ddychwelyd arian a'i henillwyd drwy drosedd yn ôl i'r gymuned.</p> <p>I sicrhau bod PACT efo digon o arian i gynorthwyo prosiectau yng Ngogledd Cymru, bydd cyfanswm o o leiaf £30k yn cael ei drosglwyddo i PACT bob blwyddyn, o'r arian yng Nghronfa Deddf Enillion Troseddau, a'r un cyfanswm o Gronfa'r Comisiynydd.</p> <p>Bydd y penderfyniad ar faint i'w drosglwyddo pob blwyddyn ariannol i'w gymryd gan un ai'r Prif Weithredwr neu'r Prif Swyddog Ariannol, ag ymgynghoriad efo Rheolwr PACT a'r Rheolwr Busnes, a'i gyhoeddi ar Ddatganiad Cyfrifon y Grŵp, sydd ar gael ar wefan y Comisiynydd.</p>	<p>The Police and Crime Community Trust (PACT) manages a portion of the Proceeds of Crime Fund on behalf of the Police and Crime Commissioner and the Chief Constable of North Wales.</p> <p>Monies from the Proceeds of Crime Fund is used to fund the Commissioner's "Your Community, Your Choice" project. "Your Community, "Your Choice" is a way of returning monies gained through crime back to the community.</p> <p>To ensure that PACT has sufficient monies to support projects in North Wales, a total of at least £30k will be transferred to PACT each year from monies held in the Proceeds of Crime Fund which will be matched by funds transferred to PACT from the Commissioner's Fund.</p> <p>The decision on the amount to be transferred each financial year will be made by either the Chief Executive or Chief Finance Officer, in consultation with PACT Manager and Business Manager, and published in the Group Statement of Accounts accessible on the Commissioner's website.</p>
