**Counter Terrorism Joint Inspection – National  
security division and multi-agency  
arrangements for the management of terrorist  
offenders in the wake of terrorist attacks.**

Yn unol â'r statud, ysgrifennaf atoch gyda fy  
sylwadau ar Arolwg ar y Cyd Arolygaeth  
Heddluoedd a Gwasanaethau Tân ac Achub Ei  
Fawrhydi (HMICFRS), Arolygaeth Gwasanaeth  
Prawf EF ac Arolygaeth Carchardai EF ar  
Wrthderfysgaeth.

As required by statute, I am writing to you with  
my comments on His Majesty's (HM)  
Inspectorate of Constabulary, Fire and Rescue  
Service (HMICFRS), HM Inspectorate of  
Probation and HM Inspectorate of Prisons'  
Counter Terrorism Joint Inspection.

Canolbwytiodd yr Arolygaeth ar drefniadau  
rheoli terfysgwyr yn sgil ymosodiadau terfysgol  
yn 2019 a 2020, hefo adolygiad a gynhaliwyd  
ledled Cymru a Lloegr. Arolwg  
Gwrthderfysgaeth ar y Cyd – Trefniadau isadran  
diogelwch cenedlaethol ac asiantaethau  
gwahanol ar gyfer rheoli terfysgwyr yn sgil  
ymosodiadau terfysgol. Mae lleoliad daearyddol  
Gogledd Cymru yn unigryw o'i gymharu â  
heddluoedd eraill gan ein bod o fewn Plismona  
Gwrthderfysgaeth Cymru, ond o fewn Uned  
Troseddau Trefnedig Rhanbarthol y Gogledd  
Orllewin.

The Inspectorate focused on the arrangements  
for the management of terrorist offenders in the  
wake of terrorist attacks in 2019 and 2020, with  
reviews conducted across England and Wales.  
The geographical location of North Wales is  
unique compared to other forces as we sit within  
Counter Terrorism Policing Wales, but within the  
North West Regional Organised Crime Unit  
(NWROCU).

Ar y cyfan, mae'r adroddiad wedi nodi gwelliant  
eang o ran rheoli terfysgwyr yn dilyn gweithredu  
mesurau ar draws carchardai, yr Isadran  
Diogelwch Cenedlaethol a Rheoli Cysylltiadau

Overall, the report has identified a vast  
improvement in the management of terrorist  
offenders following the implementation of  
measures across prisons, the National Security

Gwrthderfysgol. Mae'r adroddiad wedi amlygu arfer da mewn arweinyddiaeth gref, gweithio mewn partneriaeth a rheoli achosion ar lefel leol, rhanbarthol a chenedlaethol. Disgrifiwyd y lefel goruchwylia o fewn y gymuned fel cadarn gan ei bod yn pwysa a mesur anghenion adsefydlu hefo ffiniau rheoli risgau tynn.

Roedd meysydd i'w gwella a oedd yn cynnwys yr angen i ddiweddarau'r fframwaith gweithredol presennol o fewn carchardai a'r gwasanaeth prawf. Mae hyn wedi arwain at rywfaint o anghysondeb o ran sut y rheolir troseddwyr ledled y wlad. Rwyf yn edrych ymlaen at weld y fframwaith newydd unwaith mae wedi cael ei roi ar waith.

Mae'n gadarnhaol fod yr adroddiad hwn wedi nodi gwelliant sylweddol o ran rheoli'r garfan hon o droseddwyr yn dilyn yr ymosodiadau trasig yn 2019 a 2020. Bydd yn rhoi sicrwydd cyffredinol fod mesurau cadarn wedi cael eu rhoi mewn lle er mwyn atal digwyddiadau yn y dyfodol.

Division and the Counter Terrorism Nominal Management. The report has highlighted good practice in the strong leadership, partnership working and management of cases on a local, regional and national level. The level of supervision within the community was described as robust as it balances rehabilitative needs with tight risk management parameters.

There were areas of improvement identified which included the need to update the current operational framework within the prison and probation service. This has resulted in some inconsistency in the way that offenders are managed across the country. I look forward to seeing the new framework once it has been implemented.

It is positive that this report has identified a significant improvement in the management of this cohort of offenders following the tragic attacks in 2019 and 2020. It will provide an overall reassurance that robust measures have been put in place to prevent future incidents.
